**Haul Road Guidelines:** Haul Roads are an eligible practice under the District Cost Share program, as they address the Priority Resource Concern of erosion control. The SWCD Cost Share Program will pay for only the rock. Dollars spent on hauling and spreading the rock will not be reimbursed. Rock minimum will be 1/8 mile to a maximum of 1/2 mile per cost share application. No smaller than 3/4 minus rock will be applied. *It is recommended that rock come from a certified weed free pit (ODA certifies for free), although it is not required.* A maximum of 200 yards per application or approximately 270-280 tons, or \$2,500 maximum reimbursement per request. It is up to the landowner to provide a budget estimate of cost per yard at the time of application. No driveways will be eligible for the program, unless a technician verifies the driveway is part of the haul road system. This needs to be noted at time of application review and is the Boards discretion. Some haul roads may require a rock base, at the expense of the landowner to use as match or in-kind but will not be eligible for reimbursement. The District Cost Share program will only fund one haul road, per landowner per fiscal year. Expenses accrued before District Board approval are not eligible for reimbursement.
